

## THE ARC SEVENTEENTH (17th) ANNUAL HELICOPTER GOLF BALL DROP CONTEST RULES

1. For an entry fee of \$100.00 each participant will be entered into The Arc SEMS Seventeenth Annual Helicopter Golf Ball Drop to take place on November 8, 2021. Participants may enter more than once. Participants will be assigned a numbered golf ball(s). A maximum of 1000 golf balls will be sold.
2. **The numbered balls** will be placed randomly in a container and dropped from a helicopter on to the Canebrake Golf Course above a make shift golf hole. The participant whose numbered golf ball goes into the hole or closest to the hole will receive a check in the amount of (20) percent of the total entry fee collected with a maximum payout of \$20,000.00.
3. If multiple balls go in the hole, the winners share twenty (20) percent of the total entry fee collected (not to exceed \$20,000.00). The payout will be divided equally amongst the winning participants.
4. If no balls go in the hole, then a measurement will be held and the closest ball to the hole, measured perpendicularly from the center of the hole, will receive a check in the amount of twenty (20) percent of the entry fees collected with a maximum payout of \$20,000.00.
5. Winners will be announced immediately following the ball drop and need not be present to win. Winners will be posted on the United Way & The Arc SEMS websites by 2:00 p.m. November 9, 2021.
6. To make a donation and participate in the golf ball drop, complete the application form and mail it in or email to thearcsems@gmail.com with the appropriate credit card information or personal check. Incomplete forms will not be accepted.
7. Golf ball entries and golf ball drop will be audited by a local certified public accountant.

**PRIZES:** \* The Arc Southeast Mississippi is not responsible for winner's inability to claim or use the prize in accordance with the sweepstakes guidelines.

\* Prizes are non-transferable and non-refundable.

\* The Arc SEMS is not responsible for the postponement or cancellation of an event associated with the prize, and will not substitute the prize should this occurrence so arise. If the event should be canceled for any reason, all money collected will be refunded to donor.

\* The Arc SEMS will require verification of eligibility and identity before releasing prizes.

\* The purchase of a numbered golf ball constitutes full agreement by the purchaser to all terms and conditions set forth herein.

\* No one will be eligible to win who procures a numbered golf ball through a check returned for "insufficient funds", "closed account" or through charge to a debit or credit card that is "declined", "invalid", or "stolen".

\* Mailed application forms must be postmarked by October 20; email and phone orders must be received by November 1; and online orders must be received by November 8 at 12:00pm.

\* All entries must include name, address, age, birth date, and phone number to be eligible. Entries must be mailed to The Arc Southeast Mississippi (The Arc) P.O. Box 18800, Hattiesburg, MS 39404-8800.

\* One or more individuals (as designated on entry form) may team together to purchase a golf ball. Proceeds would be made payable subject to the same requirement with each team member following all terms and conditions set forth herein.

**The Arc SEMS, United Way, Canebrake and other sponsors** are not responsible for mail or faxes that are "lost, stolen, late, illegible, incomplete, damaged, mutilated, misdirected, altered, tampered with, or postage-due". Salaried officers of ARC Board of Directors are not eligible to enter.

\* In the event the ball drop has to be postponed due to weather or other issue(s), if 1000 are not sold, The Arc SEMS can resume selling until one hour prior to the helicopter drops the balls or the auditor has completed the count of balls.
